Commentary for the month of October 2011

General Fund net revenues during the month of October 2011 totaled \$589.2 million reflecting an increase of \$20 million when compared to October 2010.

- Individuals' tax collections were \$172 million, or 4% below estimates as a result of reduced tax withholdings implemented by the Tax Reform.
- Recently implemented excise tax on certain multinational groups is expected to offset tax reliefs implemented by the Tax Reform. The ninth payment totaled \$172 million.
- Corporate tax collections for the month of October 2011 were \$10 million below collections for the same month in 2010.
- Non-resident withholdings for the month of October 2011 registered \$30.8 million.
- October 2011 motor vehicle excise tax receipts totaled \$33 million.
- October 2011 off-shore shipments of rum collections totaled \$27 million, a 24% year-over-year increase.
- Net revenues for FY 2012 as of October 2011 totaled \$2,284 million, a 6.9% year-over-year increase.
